

The Michigan Economic Development Corporation is excited to announce the latest funding opportunities available through the Revitalization and Placemaking (RAP) program:

- Performance-based RAP grants are currently available for real estate redevelopment projects and can be applied for on a rolling basis as funds are available.

- Performance-based grants for public space place-based infrastructure projects and façade program implementation will be available in fiscal year 2025 through a competitive grant process. The application window is anticipated to be November 2024 through January 2025.





APPLICATION SCORING




- All scoring criteria is outlined for each question, including how the points are allocated or deducted if certain parts of the question are not answered.
- We aim to be as transparent as we can so applicants understand how their project will be scored
- Subgrant scoring: individual projects will be scored and the overall application will be scored based on an average score taken from the individual projects included on the application. Capacity to administer the application and overall impact will also be considered.

APPLICATION CONTENT HIGHLIGHTS

APPLICATION REQUESTS THE FOLLOWING:

- Attach letter of support from highest local official
- Project location central to vibrant downtown attach maps
- Cost Estimates from within 6 months of application submittal
- Project funding sources attach evidence of funding commitments
- Project Readiness attach site plan/site design
- Universal Design



- ➤ Keep program intention and goals at center of your project application.
- Make sure you have all attachments submitted with application(s).
- Subgrant applications should be well organized and cohesive
- ➤ Letters of Support should include maintenance of site, site programming, project impact
- > Authorized signer
- Property Control
